**The Nutfield News:** Is the only paper mailed to every home in Derry with a rural route address. **Total distribution: 9,891.**  
**The Tri-Town Times:** Is the only paper mailed to every home in Chester, Sandown, and Hampstead. **Total distribution: 8,714.**

Each paper is published and mailed every Thursday.

### Preprint Insert Guidelines:

2. Materials must be delivered freight pre-paid to our printer (call for shipping information) not less than 3-5 days prior to scheduled insertion.
3. Zoning information available upon request.

### Classifieds:

**\$1.00 a word** with a 15 word minimum, to run in all three publications

### Display Classified Ads \$22 pci

Ad runs in all three publications.

Deadlines for classified ads is 3:00 p.m. Monday for that weeks of publication, all line ads must be pre-paid.

### Guaranteed/Preferred Placement:

An additional charge of **20%** over the cost of the ad will be added to the overall cost for placement on specific pages or places in the paper.

### Mechanical Measurements:

Pages are 6 columns wide, 13 inches deep. Offset printing process. Halftones 85 lines preferred. JPGs at highest resolution, lowest compression. Digital camera images width of at least 1,000 pixels (@150 dpi resolution).

## **Deadlines:**

**Camera Ready:** Monday at 12:00 p.m. the week of publication. (Monday at 9 a.m. non-agency artwork)

**Non-Camera Ready:** Thursday at 12:00 p.m. the week prior to publication.

**NOTE:** All ads requiring a PROOF must be at the office one full working day prior to normal deadline.
